In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment and machinery in addition to the payment of any fee or charge, I do hereby waive, release, and forever discharge the YMCA and its officers, agents, employees, representatives, executors, volunteers, and all others from any and all responsibilities or liability for injuries or damages resulting from my or my family's participation in any YMCA activities at said facility or off the facility premises in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment of the YMCA.

2. Further, I hereby grant full permission to any and all of the foregoing to use, re-use, publish, and republish the same, in whole or part, individually, or in conjunction with other photographs, in any medium and for any purpose whatsoever, including (but not by way of limitation) illustration, promotion and advertising and trade, television and multimedia and to use my name in conjunction therewith if the YMCA chooses of me participating in any and all YMCA activities and/or events for any publicity and/or promotional purposes without obligation or liability to me.

3. I declare, for any minor(s) and myself that I/he/she/we is/are physically able to participate in the activities of the YMCA of the Prairie.

4. I agree to adhere to all policies set by the YMCA as written. I also agree to notify the YMCA of any change in bank information or employment that would affect my payment procedure.

5. Membership cards remain the property of the YMCA and must be surrendered upon request. I understand cards are non-transferrable and that loaning this card may subject the owner to loss of privileges.
